



**REQUEST FOR EXPRESSION OF INTEREST  
FOR PRODUCTION SERVICES**

1. The City of Taguig, through the General Fund FY 2018, intends to apply the sum of **Twenty Million Pesos (P20,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contracts for **Production Services (Lots)** for the **December 2018 Events**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The City of Taguig now calls for the submission of eligibility documents for **Production Services (Lots)** for the **December 2018 Events**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before November 5, 2018 at 9:30 a.m., 3<sup>rd</sup> Floor, Taguig City Hall. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. A complete set of Bidding Documents may be purchased by interested Bidders from the Bids and Awards Committee Secretariat upon payment of a non-refundable fee ("Fee") based on the standard rates set by the GPPB Resolution No. 04-2012 on October 26 to November 26, 2018.
4. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

| CRITERIA  | WEIGHT (%) |
|---|------------|
| 1. Applicable experience of consultant                  | 50         |
| 2. Qualification of personnel to be assigned to the job | 30         |
| 3. Current workload relative to job capacity            | 20         |

5. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. The Procuring Entity shall evaluate bids using the Quality Based Evaluation/Selection (QBE/QBS) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
7. The contract shall be completed within twenty (20) days.
8. The City of Taguig reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
