Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

 Year End 2022 Events. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
- The City of Taguig now calls for the submission of eligibility documents for Procurement of Production Services (Lots) for the Year End 2022 Events. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before September 23, 2022 at 10:00 a.m., 3rd Floor, Taguig City Hall. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
- The Bidding Documents Part I may be acquired by interested Consultants starting September 16, 2022 from the address below.
 Bidding Documents Part II may only be acquired by Short Listed Consultants upon payment of a non-refundable fee for Bidding Documents based on the standard rates set by the latest guidelines issued by the GPPB.
- 4. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list may consists of five (5) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.
 - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
- The Procuring Entity shall evaluate bids using the Quality Based Evaluation/Selection (QBE/QBS) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
- The contract shall be completed until December 31, 2022.
- The City of Taguig reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to
 contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or
 bidders.
